INTERIM ORDER

Whereas the performance and working of the State Food Testing Laboratory (SFTL) is being reviewed by the higher authorities at almost all the forums besides the Northern Zonal Council meetings and

a) Whereas, the samples are not being uploaded on the respective websites FoSCoS, SSMS and INFoLNET, and the backlog has also been accumulated at the end of the Notified Food Analyst/Lab Incharge Ms. Shamim Das,

b) And Whereas, despite repeated reminders and requests the High-End Equipment (HEE) machines at SFTL are yet to resume functioning in the best interest of the departmental working,

c) And Whereas, the Microbiology Lab is yet to start function due to many reasons including shortage of men, material and the sanctioned power load for SFTL being utilized by the Drug Controller Department, a temporary allottee, who needs to vacate the unauthorized occupation of the much needed Food Safety Lab space at the ground floor and main building,

d) And Whereas, Food Safety on Wheels (FSW) are to be rolled out on a daily basis, the various shortage of men, materials and resources are to be procured by following up with the various Govt. department,

Therefore, it has been decided that the following Field Assistants & Process Servers (FAs & PSs) will now onwards sit at lab office and help lab In-charge in getting the various pending compliances as above.

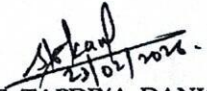
