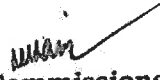

- (3) THE OFFICIALS IN SERIAL NO. 14 TILL 19 WILL NOT BE POSTED IN DISTRICT DUTY FOR SAMPLING DUTY/ENFORCEMENT WORK ETC. RELATED TO FBO PREMISES VISIT.
- (4) **No Food Safety Officer (FSO) shall conduct or attempt to conduct an inspection of any Food Business Operator (FBO) without a duly authorised Inspection Order issued under the authority of the Commissioner of Food Safety (CFS) in accordance with Section 30(2)(d) of the Act. A copy of the Inspection Order shall be handed over to the FBO at the time of inspection, and an acknowledgement of its receipt shall be obtained from the FBO and maintained in the relevant file as part of the official inspection record.**
- (5) Roster of FSW duty will be prepared by the Notified Food Analyst & VVIP Duty Roster by the D.O (HQ) with Competent approval.
- (6) Sh. Naubat Singh, FA and Sh. Sandeep Rajput, FA will be on sample duty for the labs.
- (7) Sh. Rakesh Kumar (Senior), FA & Rakesh Kumar (Junior), FA and Sh. Sunil Kumar, FA are placed under State Food Lab duty with NFA/Incharge Chemist at Lawrence Road.
