Subject: Constitution of Committee to streamline the updating of website -reg.

The Hon'ble Minister (IT) in a review meeting of Delhi Government Portal held on 07.04.2025 observed that the departments are not updating the contents on their respective websites regularly, thereby depriving the citizens of access to the latest updated position on Government policies and decisions. Consequently, a Circular was issued by the IT Department, GNCTD, dated 28.04.2025 (F.No. E-13016/26/2020-SeMT-Secy(IT)/2575-2654) directing the departments to update the contents of the website and forward a certificate of compliance to special secretary (IT) on first Monday of every month, and in case of holiday, on the next working day. Non-compliance would be viewed adversely and brought to the notice of Hon'ble Minister (IT).

2. In pursuance of the above, the Competent Authority is pleased to constitute the following committee to streamline the process of verifying the accuracy and ensuring the timely updating of content, in line with the current status of the information hosted on the official departmental website. This initiative aims to ensure that regular monitoring of website updates is carried out and institutionalized as a standard practice.

Subject: Mandatory update of the contents on departmental websites.

The Hon'ble Minister (IT) in a review meeting of the Delhi Government Portal held on 04/07/2025 observed that the Departments are not updating the contents on websites regularly, thereby depriving the citizens of access to the latest updated position on Government policies and decisions.

- The web portal has a provision for the Departments to self-update the departmental 2. contents by the web nodal officer nominated by them, and to whom the IT Department has already issued the access credentials.
- The Departments of Delhi Governments of GNCTD/ Autonomous Bodies/ Local Bodies 3. of GNCTD are hereby mandated to update the contents of the websites under their administrative control on regular basis without fail. A certificate of compliance, as per the prescribed format (Annexure - "A"), would henceforth be emailed by the HoD concerned under her/his signature to the Spl. Secretary(IT) at spl-secvit@delhi.gov.in on the first Monday of every month, and in case of holiday then on the next working day. Any non-compliance would be viewed adversely and brought to notice of Hon'ble Minister (Information Technology).

It is submitted that in pursuance of the Circular Issued by the IT Department, GNCTD, dated 28.04.2025 (F.No. E-13016/26/2020-SeMT-Secy(IT)/2575-2654) (see page 233/C) which conveys the observations of the Hon'ble Minister (IT) during a recent review meeting, wherein serious concern was expressed over the lack of regular updation of departmental websites. It was noted that such lapses hinder transparency and impede citizen access to the most current information regarding Government policies, schemes, and decisions.

- Vide the said review meeting, every Department was thus mandated to update the contents of the website on regular basis and a Compliance Certificate shall be furnished by the Head of Department to the Special Secretary (IT) on the first Monday of each month, without fail.
- 3. In this regard, it is submitted that a circular no. F.12(77)/PFA/EDP/Website/2012 dated 29.05.2025 (see page 248 /C) was issued in the department directing every section to ascertain whether the website of the Department i.e., https://foodsafety.delhi.gov.in/ reflects the most current and accurate details and mandatorily provide a certificate in this regard. The circular also directed that this exercise shall be made a set precedence and is to be followed every month.
- In the wake of the above, it is submitted that the requisite certificates have been received from the key sections of the department that are primarily responsible for updating content on the department website (viz. Dy. Commissioner, Admin, Accounts, DO (HQ), and RTI section). These certificates confirm that the information, content, and documents available online pertaining to the respective branches are complete, accurate, and up-to-date to the best of their knowledge and records. The certificates received have been placed opposite for kind perusal at pages 250-254 /C.
- It is proposed that, if approved, a committee may be constituted to streamline the process of verifying the veracity and ensuring the timely updation of content, in line with the current status of the information hosted on the official departmental website. This will serve to ensure that regular monitoring of website updates is undertaken and institutionalized as a standard practice. The exercise shall be carried out on a monthly basis, at least three days prior to the submission of the compliance certificate by the Head of Department (HoD). The committee may be constituted as follows:
 - I. Senior System Analyst - Chairman.
 - Section Officer (Admin) Member. II.
 - Designated Officer (HQ) Member. III.
 - IV. Incharge-RTI – Member.
 - ٧. Data Processing Assistant - Member.
 - VI. Food Analyst – Member.

Accordingly, in adherence to the Circular issued by the IT Department, GNCTD, dated 28.04.2025 (F.No. E-13016/26/2020-SeMT-Secy(IT)/2575-2654), if approved, the Head of the Department may be requested to accord approval and sign the compliance certificate placed opposite for onward submission to Special Secretary (IT), please.
