(iii) SCOPE OF WORK AND ACTIVITIES REQUIRED

- 1. It would be the responsibility of the selected bidder to arrange for sufficient number of dustbins, chair, tables, support staff, volunteers, water proofing of stalls, arrangement to close the stall from front side, cleanliness, etc.
- 2. The agency shall also construct Pagoda Style Food Stalls. Food Stalls are to be given three tables with frills & plastic sheets & two chairs each along with 4 light-tubes light & focus lights.
- 3. Provision for cooking area behind every food stall has to be created with water facility/dustbin etc.
- 4. All the electrical cables and wires should be properly insulated. There should not be any loose wires.
- 5. Regular removal of garbage from the dustbin. The garbage/wastes shall be collected in bags during cleaning and shall be disposed off by the agency outside the site area in disposal yard/scrap yard/location identified by the bidder and the same shall be disposed off properly through garbage disposed trucks/vans at the area as designated by the local municipality.
- 6. It shall be the responsibility of the selected bidder to set up Publicity Panel/Standees and hoardings, continuous flex panels. (ii) The selection of fabricating agency will be through Composite Quality cum Cost Based System (CQCBS). The weightage for Technical Criteria will be 70 while the Financial Criteria will be 30. The agency who quotes lowest in the financial bid shall be given 30 marks. The financial quotes of other

bidders shall be computed as follows:-

(L-1 divided by Lx) multiplied by 100 wherein X is the bid quoted by L2, L3, L4.

(iii) The technical bids must be supported by documentary proof of technically qualifying the laid down criteria and samples/photo etc of listed items and presentation. For financial bids, the offers should be restricted to only financial/price aspects. The rates per unit and the total cost be quoted and would be as per format attached.

(iv) If there is a discrepancy between the unit price and the total price that is obtained by multiplying the unit price and quantity, the unit price will prevail and the total price will be corrected. If there is a discrepancy between words and figures, the amount in words will prevail for calculation of price.

All the empanelled agencies are hereby requested to develop concept and design as per scope of work. For any further assistance and clarification, the bidders may contact the undersigned during working hours.

Special Conditions for Evaluation

The Preferred Bidder would be selected as per criteria mentioned. However, in the event that two or more Bidders secure exactly the same composite Score, then Food Safety Department, Govt. of NCT of Delhi reserves the right to declare as Preferred Bidder whose Presentation Score is highest among such Bidders who have secured exactly the same Composite Score.

7. Performance Security:

Within one (1) day from the date of the receipt of the award letter, the successful bidder shall furnish performance security to the Food Safety Department, Govt. of NCT of Delhi which shall be equal to 3% of the value of the contract and shall be in the form of a Bank Guarantee from a

nationalized/scheduled bank. The Bank Guarantee should be valid for a minimum period of 60 days beyond the tentative date of completion of entire work. No interest will be given to agency on PBG.

8. Deliverables & Timelines

All the work should be completed on or before 12:00 noon of 29.07.2022.

9. Delay in the assignment and Liquidated Damages:

(a) The selected agency shall be liable for all costs, damages, compensation, fees, charges, levies, and expenses suffered or incurred by Food Safety Department, Govt. of NCT of Delhi due to the him/their or his/their employees negligence and/or un -workman like performance of any services under this Contract, or breach of any terms of the Contract, or failure to carry out any of the obligations under the Contract. The decision of the Food Safety Department, Govt. of NCT of Delhi regarding such failure of the Successful Agency and their liability for the losses, etc. suffered by Food Safety Department, Govt. of NCT of Delhi and quantum of such losses, shall be final and binding on the Successful Agency and Food Safety Department, Govt. of NCT of Delhi is entitled to recover all such losses from them.

(b) Without prejudice to generality of the foregoing and subject to force majeure, the parties to this contract treat time as the essence of this contract and it is an additional condition of the Contract that in the event of failure of the Successful Agency to complete any assignment within the stipulate time or if the work remains uncommented/or incomplete at any stage with reference to time prescribed and reason for delay cannot be satisfactorily substantiated, without prejudice to the other remedies available to The Food Safety Department, Govt. of NCT of Delhi under this contract and in Law, the Successful Agency shall be liable to pay Food Safety Department, Govt. of NCT of Delhi Liquidated Damages @ 0.5% of the value of the contract which the parties to the contract having agreed to as reasonable pre estimate of the losses to Food Safety Department, Govt. of NCT of Delhi arising on account of such failure, subject to upper ceiling.

(c) If in the opinion of Food Safety Department, Govt. of NCT of Delhi, the delay in completion of assignment is delayed unduly, it shall be lawful for Food Safety Department, Govt. of NCT of Delhi to terminate the contract at the risk and cost of such agency and to forfeit the performance guarantee for recovery of all loses/damages/cost and expenses which may be incurred by Food Safety Department, Govt. of NCT of Delhi consequent to such termination.

10. Penalty:

In case the agency fails to complete the work as per the Food Safety Department, Govt. of NCT of Delhi requirement within stipulated period penalty of 0.5% of the total value of the project

will be charged as penalty for every week of delay, upto maximum of 5% of the total value of the project.

11. Transfer and Sub-letting: The agency has no right to give, bargain, sell, assign or sublet or otherwise dispose of the Contract or any part thereof, as well as to give or to let a third party take benefit or advantage of the present Contract or any part thereof.

12. Force Majeure: In the event of either party being rendered unable/helpless by Force Majeure to perform any obligation required by them under the contract, the relative obligation of the party affected by such Force Majeure shall be suspended for the period during which such cause lasts with the approval of the other party. It is clarified that in case, the Force Majeure event occurs due to negligence of agency, then the provisions of this clause shall not apply. Upon the occurrence of such cause and upon its termination, the party alleging that it has been rendered unable/helpless as aforesaid thereby, shall notify to the other party in writing within 07 (seven) days of the alleged

beginning and ending thereof giving full particulars and satisfactory proof. If deliveries are suspended under Force Majeure conditions lasting for more than 2 (two) months, Food Safety Department, Govt. of NCT of Delhi shall have the option of cancelling this contract in whole or part at its discretion without any liability on its part.

13. Other Conditions:

(i) No advance payment will be made. However, the payment will be released after satisfactory completion of the work and receipt of invoice.
