**MINUTES OF THE MEETING HELD UNDER THE CHAIRMANSHIP OF COMMISSIONER (FOOD SAFETY)  
ON 19.12.2013 AT 12.00 PM TO DISCUSS THE ACTIONABLE POINTS FORWARDED BY FSSAI.**

A meeting was held under the chairmanship of Commissioner, Food Safety on 19.12.13 at 12:00 noon which was attended by Special Commissioner Food Safety, and all Designated Officers. The following points were discussed and decided:-

1. The Commr.(FS) emphasized that FSSAI has issued directions that till 30.11.2013 all the states are required to submit an estimate of number of FBOS in the State. This issue was discussed a number of times and all the Dos were directed to submit the estimates but none of the DOs has submitted the required information in a satisfactory manner till date. All the Dos are directed to submit the information to DO(Lic.) by 26.12.2013 ( F/N ).
2. Special Commissioner, Food Safety stated that to reach at a reasonable estimate of number of FBOs in detail, each DO shall identify the markets and market associations within their jurisdiction and thereafter the estimate of the number of FBOs in each market should be assessed.
3. Commr.(FS) stated that the department is shortly going to issue online licensing of FBOs by using FLRS system. All the Dos were directed to get their FSOs and other staff acquainted with the system and prepare them for the said purpose so that as and when online licensing of FBOs is started, all Dos, FSOs etc. are able to handle the licensing applications online.
4. Commr.(FS) stated that FSSAI has invited suggestions for amendments in the FSS Act, Rules & Regulations. Various points relating to such suggestions were discussed in detail. DO(HQ) was directed to compile all such suggestions and put up the file within a week's time so that FSSAI could be informed accordingly.
5. FSSAI had also directed the states to identify the trainers who will undergo a training of trainers programme through a centralized training by 15.10.2013. DO(Misc.) who is dealing with the subject was directed to get the names approved from the Commr.(FS) within a week's time and send the said names to the FSSAI.
6. Commr.(FS) desired that the time schedule discussed in the meeting must be adhered by all concerned.

7. For decision about appointment of Milk Commissioner as D.O a separate meeting was held on 19.12.2013 at 4:00 pm in which it was decided that DO's of respective district shall continue to be DO for Milk Plants also as there is no post of Milk Commissioner in Delhi.
