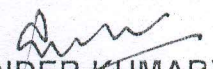
A meeting was convened under the chairmanship of Commissioner Food Safety with the officers of the Department, local body representatives, police officers of the respective area and NGO-NASVI.

The following points were discussed during the meeting:-

1. Commissioner Food Safety reviewed the progress of the DOs regarding data collection on street food vendors. It was emphasized that the area/market selected by D.O. should be accessible and visible to the visitors/tourists so that they get the opportunity to taste the flavour of street food in hygienic condition. This is the endeavour of the department that the food served by these street food vendors is tasty as well as hygienic, the way it is served by them to the masses.
2. Commissioner Food Safety also enquired about the progress of DO(East) in his area. Sh. Shyam Lal, DO(East) has given the basic data collected by him in the area of Krishna Nagar, East Delhi. The C.F.S. directed Shri Shyam Lal, DO to visit the area again with the FSOs, local body officers and NASVI representatives and interact with the street food vendors. C.F.S. also informed that if needed he will talk to the Commissioner(EDMC) for cooperation from EDMC Department. He also requested the officers of the Police Department for extending their cooperation. The progress in Sarai Kale Khan area (South East District) was also found unsatisfactory as

week's time. The prescribed performa to be got filled up from individual vendors and its abstract be completed within week's time and put up on file.

3. Sh. R.P. Singh, FSO presented the data of the street hawkers of Sarojini Nagar Market. He informed that the hawkers were interested in the project and they actively participated in the interaction with the officers of the Department. The officers of NDMC have also approved the site for the project.
4. Sh. Mukesh Kumar Gupta, D.O. has told that he has collected the data from the Tilak Nagar Market (West District). He found that the vendors are interested in the project. About 25 vendors have already been identified. Beside there are zonal mobile vendors which are being identified with the help of NASVI. The Dy. Health Officer of the West Zone also agreed with the site and proposal of development of street food vendors.
5. Commissioner Food Safety noticed that no one from City Zone has visited the areas like Katara Neel, Karol Bagh & Pahar Ganj. He has directed Shri A.K. Singh and Sh. Satish Gupta, FSOs to personally visit the areas on Wednesday, Thursday & Friday respectively along with the representatives of NASVI. They can take guidance from Local police and MCD officers of the concerned area.
6. The DOs concerned were directed by the C.F.S. to personally supervise & report in a week time, so that DPR can be sent to FSSAI.
