1. Aims and objectives of the organization

- To enforce the provisions of The Food Safety and Standards Act, 2006 and Rules 2011 in NCT of Delhi.
- To regulate manufacture, storage, distribution, sale, import etc. so as to ensure the availability of safe and wholesome food for human consumption.

2. <u>Mission/Vision</u>

Vision

To create an enabling environment for all Food Business Operators in Delhi to comply with norms for safety and standards established under the Food Safety and Standards Act 2006, Rules and Regulations 2011, and ensure availability of safe and wholesome food to the citizens of Delhi.

Mission

- To coordinate and plan with Food Business Operators to implement Food Safety Management System in a time bound manner.
- Initiate and carry out capacity building and training of Food Business operators to enhance technical knowhow and commitment for implementation of scientific system of food safety management, including storage, manufacturing and distribution practices.
- To carry out awareness generation amongst consumers to adopt practices of self regulation.
- To empower consumers to check and monitor the standards of food.

3. <u>Brief history and background of its establishment</u>

Consequent upon the major amendments in PFA Act 1954, the Department of Prevention of Food Adulteration was set-up by the then Delhi Administration in the year 1976 for implementing the provisions of the Prevention of Food Adulteration Act-1954.Before the year 1976, implementation

of the PFA Act and the relevant Rules was the responsibility of the Local Bodies (M.C.D., N.D.M.C., Delhi Cantt Authorities) Further the Food Safety & Standard Act 2006 was introduced by the Govt. of India and its Rules And Regulations made there under came into force w.e.f.5.8..2011. The Department has been renamed as Food Safety Department.

5. Allocation of business

- 1. To carry out the survey of the Industrial units engaged in the manufacture or processing of food in the State to find out complaints by such units of the Standards notified by the Food Authority for various articles of Food.
- 2. To prohibit in the interest of public health, the manufacture, storage, distribution or sale of any article of food, either in the whole of the State or any area or part thereof.
- 3. To conduct or organize training programs for the personnel of the office of the Commissioner of Food Safety for generating awareness on Food Safety.
- 4. To sanction prosecution for offences punishable with imprisonment as well as fine.
- 5. To ensure that no person carries on any food business except under a license.
- 6. To take samples of any food or any substance which appears to be intended for sale for human consumption and there is a reason to believe that the same is in contravention of the Food Safety and Standard Act for the Regulations made there-under.
- 7. To test the food samples lifted from Food Business Operators in the Food Laboratory for contravention of the standards laid down in the Food Safety & Standards Act/Regulations.
- 8. To investigate any complaint, which may be made in writing in respect of any contravention of the provisions of this Act/Rules/Regulations.

6. Duties to be performed to achieve the Mission.

- 1. Lifting of samples of Food articles from Food Business Operators.
- 2. Testing the food samples in the Food Laboratory for violation of standards.
- 3. Launching prosecution in case of failed samples.
- 4. Organizing training programs for consumer awareness.

- 5. Organizing training programs for field staff of the department.
- 6. Issuance of License/Registration Certificates to all the Food Business Operators to regulate manufacture, storage, distribution, sale, import etc
- 7. To ensure that prohibited articles are not available in the entire area of Delhi for human consumption.


